Consumers who receive and pay their bills online spend less time writing checks, mailing payments, tracking due dates, and filing paperwork, and time is a valuable asset in today's fast paced environment. week and will be accessible through

www.pwsd9.com. Customers who sign up for the service will receive an email with their current amount due and a printable PDF version of their bill that is an exact replica of the one they receive in the mail. Residents don't need to sign up to view and pay their bills. Registration is only required to

use the account management features. After paying their bill online, all customers will receive a payment receipt in their email inbox, or if they don't have email it can be printed directly from the computer screen. Customers can also access previous months' bills and payment history. Once

they are logged onto the web portal, customers can search their payment history, schedule a one-time payment or establish an automatic payment schedule.

Rate Increase

Effective September 1, 2013 the usage rate on your water bill will increase to \$3.65 per 1000 gallons. This will reflect on your September usage bill, which you will receive the first of October. The District annually reviews income and cost, and after experiencing increases by its providers, the District needed to raise the current rate. This is the

first increase since September 2011.
